Terms of Use incorporated herein, carefully. If you do not wish to be bound by the Terms of Use, TRImages, Ink. will not be able to perform Creative Services for you.

Terms Applicable to TRImages, Ink. Creative Services

1. General Terms Applicable to TRImages, Ink. Creative Services.

(a) If you are requesting a Creative Services project on behalf of any business, organization, or other entity of any kind, you represent and warrant that you are authorized to accept these terms on its behalf and to bind such business, organization, or entity to these Terms of Use.

(b) If you provide TRImages, Ink. with any text, images, designs, or other content for incorporation into your Creative Services project, you unconditionally guarantee that you have all appropriate and necessary right and authority to use such text, images, designs, or other content and that your use will not infringe any trademark, copyright, or other right of any other party.

(c) The designs and/or written copy (collectively, "Designs") prepared by TRImages, Ink. for you as part of your Creative Services project may have similarities to Designs prepared by TRImages, Ink. for other parties. You are obtaining no right or claim of any kind to any individual Design element or elements provided by TRImages, Ink. and TRImages, Ink. reserves the right to use the same or similar Design elements in other Creative Services projects or otherwise for other parties in the future. Except for the specific Creative Services project content provided to TRImages, Ink. by you, all rights in all Creative Services work product, including without limitation both final Designs and all interim and draft Designs, are retained by TRImages, Ink. Your right to use any Designs prepared by TRImages, Ink. for you is limited to the finished printed products in the form they are supplied to you by TRImages, Ink. You may not copy, disassemble, modify, or transfer any such Designs.

(e) TRImages, Ink. reserves the right, in TRImages, Ink.'s sole discretion, to refuse to accept any Creative Services project or to terminate any Creative Services project prior to completion at any time and for any reason. You agree that TRImages, Ink. shall have no liability of any kind to you or to any third party arising from such refusal or termination.

(f) TRImages, Ink. reserves the right to make changes to these Terms of Use and to the products and services offered by TRImages, Ink. Creative Services at any time without prior notice. You should review these Terms of Use, and the incorporated TRImages, Ink. Terms of Use, each time you request a Creative Services project.

(g) TRImages, Ink. reserves the right to use any Designs and/or your finished Creative Services project products as sample work for advertising and promotional purposes and for internal purposes.

2. Terms Applicable to Delivery of Designs and Pre-paid Fees.

(a) Payment for any and all creative services to be provided by TRImages, Ink. Creative Services is due in advance of any work by TRImages, Ink. Creative Services.

(b) Initial Design concepts are expected to be delivered to you within 5 business days of your initial order provided all content and information needed from you is completed and received. Your Designs will be delivered to you by email notification, or by web upload to your Customer e-Document page which you must view by logging in to your TRImages, Ink. account with your previously provided user ID and Password. If the email address you provide is not valid or is filtered by your email system, TRImages, Ink. Creative Services will not be liable for any missed deadlines and will not refund clients for this reason.

(c) Other fees may apply for Image Processing, Multiple varieties of the same document, File Conversion, and Revisions beyond the number, if any, provided with the initial fee.

3. Acceptance and Cancellation.

(a) Projects may be cancelled within 2 business days of the initial design work being completed by the TRImages, Ink. Creative Service Consultant/Team and placed in your TRImages, Ink. account for review (either in your secure online e-Document page, or via email service). If you do not cancel your Creative Services project within that 2-business day period, you will be deemed to have accepted such Designs, and any/all amounts paid or payable by you for the Creative Services project will be nonrefundable.

(b) If cancelled within the 2-business day acceptance period you would be entitled to a full refund of pre-deposited monies, less any pre-purchased supplies (ex: software, hardware, URL/Web hosting fees, etc.) that were incurred by TRImages, Ink. on your behalf in order to complete the originally contracted Design project.

4. Additional Customer Requirements.

(a) You must be 18 Years old or older to purchase a Creative Services project and utilize TRImages, Ink.'s Creative Services.

(b) It is your responsibility to provide images, or other content if needed to complete the project. You must contact TRImages, Ink. with any changes, updates, or enhancements to the project you are requesting starting from date of sale.

5. Damages and Liabilities

(a) TRImages, Ink. Creative Services disclaims and shall not be liable for any other loss, injury, cost or damage suffered by Customer or any third party and shall in no event be liable for consequential, special, or indirect or incidental damages, including without limitation, damages for loss of business profits, business interruption, or loss of data, arising out of or in any way connected with the use of the product Designs and any information available on it, and the delay or inability to use the TRImages, Ink. site or any information, even if TRImages, Ink. has been advised of the possibility of such damages.

(b) All delivery times are estimates only, and TRImages, Ink. is not responsible for any late Creative Services projects and/or impact to Customer's business due to a late project and/or printing. TRImages, Ink. advises that Customers plan at least one month for any Creative Services project and associated printing and shipping time.

Terms Applicable to Logo Design Services
